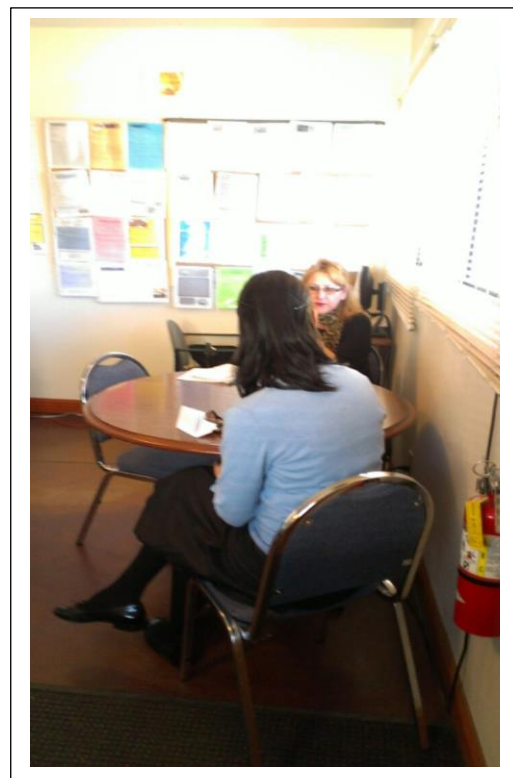

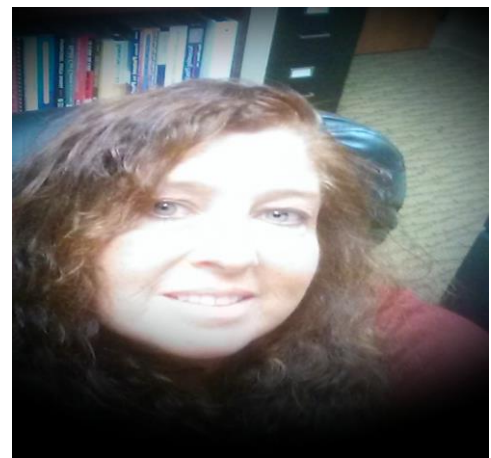

In working with NorCal Truck School, Bryant passed all prerequisites for training. After making arrangements to live onsite, Bryant began training on July 15, 2013. In August, we discovered that Frank's old position at TC Construction had reopened. Frank took his new resume, applied, and got the job.
